PT Bursa Komoditi dan Derivatif Indonesia (BKDI) dan PT Indonesia Clearing House (ICH), dengan ini BKDI dan ICH menetapkan ketentuan-ketentuan sebagai berikut:

PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") and PT Indonesia Clearing House ("ICH"), ICDX and ICH hereby stipulate the terms as follows:

**I. PENANGGUHAN MEKANISME TRANSAKSI
BULLETION BOARD**

1. Terhitung sejak tanggal efektif surat edaran ini, perdagangan Timah sebagaimana dalam SEB Nomor 354/SEB/ICDX-ICH/VII/2022 tentang Ketentuan Transaksi *Bulletin Board* dengan ini dilakukan penangguhan sampai dengan batas waktu yang akan ditetapkan kemudian.
2. Seluruh Anggota BKDI dan ICH yang melakukan transaksi dengan mekanisme *Bulletin Board* akan dialihkan ke mekanisme transaksi *Block Trade* sesuai dengan ketentuan yang berlaku pada BKDI dan ICH.

II. KETENTUAN LAIN

1. Ketentuan dalam Surat Edaran Bersama ini akan berlaku efektif pada tanggal 11 Juni 2024
2. Ketentuan-ketentuan dalam Surat Edaran Bersama ini dapat diubah dari waktu ke waktu.

**I. SUSPENSION OF BULLETION BOARD
TRANSACTION MECHANISM**

1. Starting from the effective date of this circular letter, Tin trading as stated in SEB Number 354/SEB/ICDX-ICH/VII/2022 concerning Bulletin Board Transaction Provisions is hereby suspended for a certain period of time that will be determined later on.
2. All BKDI and ICH members who carry out transactions using the Bulletin Board mechanism will be transferred to the Block Trade transaction mechanism in accordance with the provisions applicable to BKDI and ICH.

II. MISCELLANEOUS

1. The provisions set forth in this Joint Circular shall be effective on 11 June 2024.
2. Provisions as referred to in this Joint Circular are subject to change from time to time.
