PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") dan PT Indonesia Clearing House ("ICH"), menetapkan ketentuan transaksi di *Block Trade* sebagai berikut:

PT Bursa Komoditi dan Derivatif Indonesia ("ICDX") and PT Indonesia Clearing House ("ICH") hereby stipulate the terms of transaction in Block Trade as follows :

I. PERUBAHAN KETENTUAN

1. Mengubah huruf a pada poin I. **Ketentuan Umum** sehingga huruf a untuk selanjutnya menjadi berbunyi sebagai berikut :
 - a. Jam Perdagangan :
10.00 – 16.30 WIB

I. AMANDMENT OF PROVISIONS

1. To amend letter a in point I. **General Provisions** so that letter a henceforth reads as follows:
 - a. Trading Hours :
10.00 – 16.30

II. KETENTUAN LAIN-LAIN

1. Ketentuan dalam Surat Edaran Bersama ini berlaku efektif sejak tanggal ditetapkan.
2. Ketentuan-ketentuan lainnya dalam Surat Edaran Bersama No. : 355/SEB/ICDX-ICH/VII/2022 dan No. : 396/SEB/BKDI-ICH/VI/2024 tetap berlaku sepanjang tidak diubah oleh Surat Edaran Bersama ini.
3. Ketentuan-ketentuan lainnya yang belum diatur dalam Surat Edaran Bersama ini tunduk pada Peraturan yang berlaku termasuk dan tidak terbatas pada Peraturan dan Tata Tertib ICDX dan ICH.

II. OTHER PROVISIONS

1. The provisions set forth in this Joint Circular shall be effective from the issuance date.
2. Other Provisions in Joint Circular Letter No. : 355/SEB/ICDX-ICH/VII/2022 and No. : 396/SEB/BKDI-ICH/VI/2024 remain in effect as long as they are not amended by this Joint Circular Letter.
3. Other Provisions that have not been stated in this Joint Circular are subject to the applicable regulations including and not limited to the Rules and Regulations of ICDX and ICH.

4. Ketentuan- ketentuan dalam Surat Edaran bersama ini dapat diubah dari waktu ke waktu.

4. Provisions as referred to this Joint Circular are subject to change from time to time.
