Sehubungan dengan akan dimulainya perdagangan *Renewable Energy Certificate* ("REC"), maka PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") dan PT Indonesia Clearing House ("ICH") menerbitkan Surat Edaran Bersama yang menetapkan ketentuan mengenai struktur biaya transaksi REC sebagai berikut:

In the connection with the commencement of the Renewable Energy Certificate ("REC"), PT Bursa Komoditi dan Derivatif Indonesia ("BKDI") and PT Indonesia Clearing House ("ICH") issue a Joint Circular Letter which enact the REC transaction fee structure as follows:

**I. STRUKTUR BIAYA TRANSAKSI REC**

**I. REC TRANSACTION FEE STRUCTURE**

| Biaya Transaksi Pasar Premium / <i>Premium Market Transaction Fee</i> | IDR 950/MWh        |

**Keterangan:**

- Biaya Keanggotaan:**  
Biaya Keanggotaan didasarkan pada tahun kalender keanggotaan.
- Biaya *retirement* dengan I-REC Standard sebesar USD 0.11/MWh dan biaya tersebut akan diteruskan secara langsung ke I-REC Standard (*Evident Registry*).
- Biaya keanggotaan dan transaksi yang dibebankan belum termasuk pajak berdasarkan ketentuan pajak di Republik Indonesia.

**Remarks:**

- Membership Fee:**  
Membership Fee is based on the membership calendar year.
- Retirement fee with I-REC Standard in the amount of USD 0.11/MWh will be forwarded directly to the I-REC Standard (*Evident Registry*).
- Membership and transaction fee imposed are exclusive of taxes in accordance with the taxation regulations in Republic of Indonesia.
